## **CAPABILITY REPORT**

# **General Information for all Host Nation appointments:**

- No siblings allowed.
- Hospitals and clinics require patients to report to their appointments 20 minutes prior due to COVID screening procedures.
- Masks are mandatory.
- Family members of adult patients must wait outside the Hospital grounds.
- Only one parent is authorized to accompany their child in the Hospital Grounds for medical care.

# **Hospital Specific Information:**

#### 1. PORDENONE HOSPITAL

- a. OBSTETRICS -
- OB patients must continue to report to their prenatal care appointments unaccompanied. Family members may be required to wait outside the Hospital grounds.
- Moms and newborn baby must report to post-natal follow-ups unaccompanied.
- No siblings allowed.
- At delivery, only one person is authorized to accompany the OB patient.
- Day after delivery: only partners are authorized to visit between the hours of 1500 to 1600.

## ALL OTHER SPECIALTIES & DEPARTMENTS:

- a. Spirometry appointments: limited appointment availability until further notice.
- b. Day Hospital (Internal Medicine): specialty appointments temporarily suspended until further notice.
- b. Building L is the sole point of entry to the Hospital grounds. Temperature checks and other screening processes are in place.

### 2. **CRO**

- a. Patients must report 30 minutes prior to all scheduled appointments for pre-Triage.
- b. Radiology Services: routine business operations.
- c. Patients will be required to complete a screening form and bring it to the appointment.

### 3. POLICLINICO

- a. OBSTETRICS:
- OB patients must report to their prenatal care appointments unaccompanied.
- Moms and newborn baby must report to post-natal follow-ups unaccompanied.
- At delivery, only one person is authorized to accompany the OB patient.
